March 2015 WBST Board Meeting Minutes

- Pam Hartman presented financial status updates for pistol and shotgun teams' accounts payable and accounts receivable (available for viewing upon request)
- Board discussed the creation of the new TNSPP that will increase athlete membership \$15 more.
 We asked Tammy Mowry for clarification as to what this organization is, what the fees cover, and if the fee is required. Waiting on response from Tammy.
- Pistol program will host a competition on August 22 at ORSA. Clubhouse is reserved for lunch fundraiser and auction fundraiser.
